Attendance is monitored and the Board may decide to change the membership to Inactive and levy the additional R500 at any time, depending on circumstances. The additional R500 will be payable immediately. Failure to do so, may result in a termination of Membership. Long Distance/Remote members who assist are also regarded as Active Members.
